I warrant that I have never been convicted of a felony and I further warrant that I shall not engage in any obscenity and I agree to indemnify, pay the costs of defense, and hold harmless Nekkid.Net, Inc. and its officers, directors, affiliates, attorneys, shareholders, agents, assigns, from any and all claims brought by third parties arising out of or related to my conduct, statements, or actions during any appearance(s) I make for Nekkid.Net, Inc. I understand that I am being contracted as a third party vendor to act, and I am personally responsible for any taxes owed. Any and all disputes arising out of this agreement shall be submitted to binding arbitration according to the rules of the American arbitration association and shall be resolved exclusively in Folly Beach, South Carolina with the American Arbitration Association. This agreement shall be governed exclusively under South Carolina law and exclusive jurisdiction shall be in Folly Beach, South Carolina.
